

The title Technical Mechanics seems fairly appropriate for this book; and inasmuch as it is not otherwise used in this country, it was so adopted. On the theoretical side, practically each subject discussed herein has a direct bearing on some engineering problem. The applications were selected and presented for the purpose of illustrating a principle of mechanics and for training students in the use of such principles, not to furnish information, except incidentally, about the structure, machine, or what not to which the application was made.
