On the theoretical side, practically each subject discussed herein has a direct bearing on some engineering problem. The applications were selected and presented for the purpose of illustrating a principle of mechanics and for training students in the use of such principles, not to furnish information, except incidentally, about the structure, machine, or what not to which the application was made.
