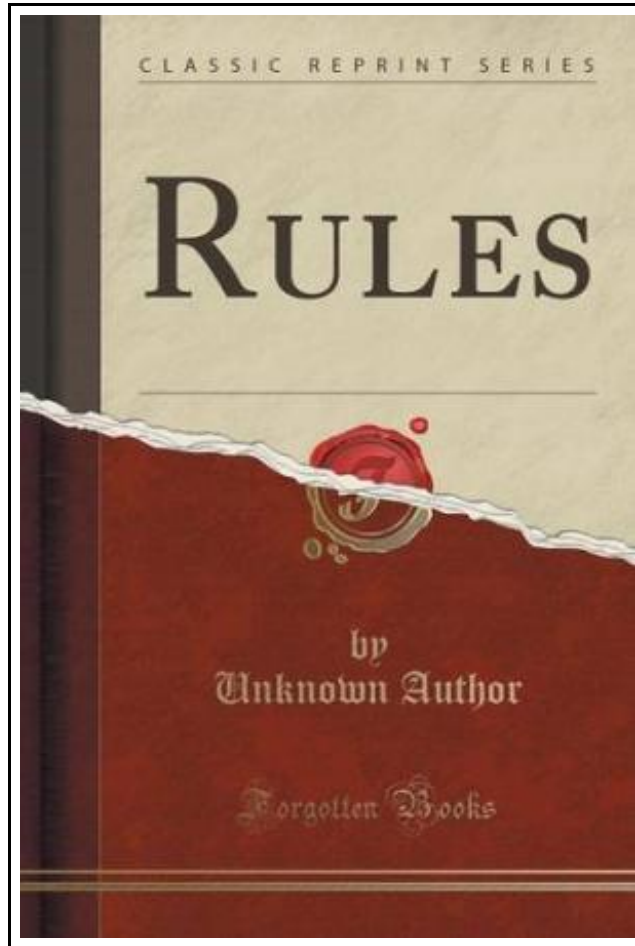

This society shall be called the Pendleton Co-operative Industrial Society Limited. The objects of the society are to carry on the trades of general dealers, both wholesale and retail, also of manufacturers; and shall have power to purchase, hold, sell, mortgage, rent, lease, or sublease land of any tenure, and to erect, pull down, repair, alter, or otherwise deal with any building thereon. Registered Office. 3. The registered office of the society shall be No. 1, Gloucester Street, Pendleton, in the County of Lancaster, or such other place as the committee of management shall from time to time appoint; and at such place all the books of accounts, securities, and documents of the society, other than such (if any) as are required for carrying on business on account of the same elsewhere, shall be kept. In case of Removal of removal of the registered office, notice shall be sent to the Registrar of Friendly Societies within fourteen days thereafter, in the form provided by the Treasury Regulations. Admission of Members. 4. The society shall consist of the present members and of all other persons who shall be admitted in the following manner: - No person shall be admitted as a member except by the committee of management; every person proposed shall pay an entrance fee of 1s., and 3d. for a copy of rules, and must sign a declaration of his willingness to take out at least three shares, and be bound by the rules of the society. A person not signing the declaration, and not paying a deposit within six months after his proposition, shall forfeit his entrance fee, and shall not be admitted to membership...
